# STOCK PURCHASE AGREEMENT

This Stock Purchase Agreement (the "Agreement") is made and entered into on this February 10th 2024 (the "Effective Date"), by and between;

M/s. Gujarat Kidney and Super Specialty Limited, (CIN U85300GJ2019PLC11159), is a Company incorporated and registered under the Companies Act, 2013, having its registered office at Plot No. 1, City Survey No. 1573/A, Jetalpur Road, Gokak Mill Compound, Alkapuri, Vadodara, Gujarat. (hereinafter referred to as the "Buyer"),

#### AND

M/s New Gujarat Pharmacy, a proprietorship firm, owned by Anitaben Yashwantsinh Bharpoda having its PAN No. ABAPN7107Q., having its registered office at Plot No. 1, City Survey No. 1537/A, Jetalpur Road, Gokak Mill Compound, Alkapuri, Vadodara, Gujarat (hereinaster referred to as the "Seller").

#### RECITALS

WHEREAS, the Seller is the lawful owner of certain inventory of medicines and related goods as listed in Schedule A of this Agreement (the "Inventory");

WHEREAS, the Buyer has agreed to purchase from the Seller, and the Seller has agreed to sell to the Buyer, the Inventory, on the terms and conditions set forth in this Agreement;

NOW, THEREFORE, in consideration of the mutual promises, covenants, and conditions set forth herein, the parties hereto agree as follows:

## 1. SALE OF INVENTORY

- 1.1 Inventory Description: The Seller agrees to sell, and the Buyer agrees to purchase, the Inventory which includes all stock of medicines and related goods as at February 10, 2024. The Inventory is further detailed in Schedule A, which is attached hereto.
- 1.2 **Price of Inventory**: The total purchase price for the Inventory is 27,32,783.70 (Twenty-seven lakh thirty-two thousand seven hundred eighty-three rupees and seventy paise) Further the inventory so purchased will be inclusive of the value of

the Central Goods and Service Tax (CGST), State Goods and Service Tax (SGST), and Integrated Goods and Service Tax (IGST), as applicable.

- 1.3 Payment Terms: The Buyer shall pay the total purchase price as set forth in Clause 1.2 on or before 30/06/2024 via Bank Transfer.
- 1.4 Taxes: The Buyer acknowledges that the purchase price of the Inventory is inclusive of all applicable taxes, including CGST, SGST, and IGST, and agrees to bear the tax liability as applicable under the prevailing laws.

#### 2. TRANSFER OF INVENTORY

- 2.1 **Transfer of Ownership**: Upon full payment by the Buyer, the Seller agrees to transfer all rights, title, and interest in the Inventory to the Buyer as of the date of payment (the "Closing Date").
- 2.2 **Delivery**: The Seller shall deliver the Inventory to the Buyer at Plot No. 1, City Survey No. 1537/A, Jetalpur Road, Gokak Mill Compound, Alkapuri, Vadodara, Gujarat, and all costs associated with the transportation and delivery of the Inventory shall be borne by the Buyer.

## 3. REPRESENTATIONS AND WARRANTIES

- 3.1 Seller's Representations: The Seller represents and warrants to the Buyer that;
- (a) The Seller is the lawful owner of the Inventory and has full authority to sell the Inventory;
- (b) The Inventory is free from all encumbrances, claims, and liabilities;
- (c) The Inventory has been duly accounted for and includes all taxes, including but not limited to CGST, SGST, and IGST;
- (d) The Seller is in compliance with all applicable laws concerning the sale and transfer of the Inventory.
- 3.2 Buyer's Representations: The Buyer represents and warrants to the Seller that:
- (a) The Buyer has the full power and authority to enter into this Agreement and perform its obligations hereunder;
- (b) The Buyer is purchasing the Inventory for lawful business purposes and not for resale, unless otherwise agreed in writing.

## 4. CONFIDENTIALITY

4.1 **Confidentiality Obligations**: Both parties agree to keep confidential all details and terms of this Agreement, as well as any proprietary information exchanged during the negotiation and performance of this Agreement, unless required to disclose by law or regulation.

#### 5. INDEMNITY AND LIMITATION OF LIABILITY

- 5.1 **Indemnity by Seller**: The Seller agrees to indemnify and hold harmless the Buyer from any claims, losses, or damages arising from any breach of the Seller's representations, warranties, or obligations under this Agreement.
- 5.2 **Indemnity by Buyer**: The Buyer agrees to indemnify and hold harmless the Seller from any claims, losses, or damages arising from the Buyer's use or handling of the Inventory after the Closing Date.

#### 6. MISCELLANEOUS

- 6.1 Governing Law: This Agreement shall be governed by, and construed in accordance with, the laws of Gujarat and as applicable in the sovereignty of India.
- 6.2 **Dispute Resolution**: That any dispute arising between the parties hereto shall be referred to the sole arbitrator as required by Arbitration and Conciliation Act, 1996 the decision/award of such arbitrator shall be binding upon the parties hereto. The said proceedings will take place in Vadodara, Gujarat, India.
- 6.3 **Entire Agreement**: This Agreement constitutes the entire agreement between the parties with respect to the sale and purchase of the Inventory and supersedes any prior agreements, representations, or understandings, whether written or oral.
- 6.4 Amendment: Any amendments to this Agreement must be made in writing and signed by both parties.
- 6.5 Severability: If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement as of the Effective Date.


